## 1. PAYMENT OF FEES

All fees will only be due after your renewal application has been approved whereupon an invoice will then be raised for payment.

# 2. ANNUAL SUBSCRIPTION

The annual membership subscription is due at the onset of new membership period on acceptance of renewal of membership.

Note: Companies renewing in any month after the beginning of the financial year will be invoiced in full for annual subscription fees.

**3.** MONTHLY CLEANER LEVIES – (This levy calculation is based on Permanent cleaner no's.) Payment of the monthly levy will commence in the month the company is accepted as a member.

Fully Compliant at time of renewal	Cleaner levies will be invoiced based on audit no's as at time of renewal, i.e. for the 12-month period.	2024/2025 Membership certificate issued.
Compliant at time of renewal (audit due in latter part of the membership period	Cleaner levies will be calculated pro-rata based on a signed renewal membership application, and the remainder of the month's levies billed at the outcome of compliant audit.	Initial Membership certificate for 2024/2025, will be issued valid up until date of next audit due.  NB. An updated Membership Certificate will be issued for duration of membership period, based on a compliant audit outcome, and payment received as per invoiced for the remainder of the cleaner levies due for the 2024/2025 membership period.

# 4. NCCA ÁNNUAL COMPLIANCE AUDITS

Subscription fees and non-compliant audits.

Fees are non-refundable in the event of a non-compliant audit, (as the cost of this audit is covered by the NCCA); however, new membership or renewal of membership will not be granted, until non-compliance has been rectified.

# Note: - Requesting a follow up NCCA compliance audit

In the event of a non-compliance audit, a request for a second audit within the same financial period, would lead to the cost of the second audit being borne by the member/applicant.
