BENEFITS OF MEMBERSHIP

NCCA Recognition and Advocacy - The NCCA was established in 1987 with the goal of creating professionalism in the cleaning industry and is officially recognised as an Employers Association by the Department of Employment and Labour.

<u>Code of Ethics</u> - NCCA members commit themselves to a <u>Code of ethics</u> ensure that customers can rely on their adherence to business norms and standards.

<u>NCCA Membership Certificate</u> - A NCCA membership certificate is a guarantee that the holder complies with all the statutory legislation applicable to the contract cleaning industry in South Africa.

Ensuring Compliance - During a NCCA compliance Audit, an experienced, independent compliance auditor will verify compliance. This benefits customers by reducing the exposure to financial and reputational risks associated with using the services of a non-compliant service provider.

<u>Compliance workshops -</u> These workshops are offered on a regular basis with no cost to members. These workshops are aimed at assisting members in ensuring compliance and understanding the benefits thereof.

NCCA Members Handbook - This handbook is a resource provided to members and offers a basic guideline relating to the legislative requirement within the Contract cleaning industry.

Tender Access - A link to access tenders is made available to members, which is updated regularly.

<u>Advice on Labour Relations Contractual Matters -</u> Although the NCCA cannot become directly involved in any labour disputes, members have access to advice on labour matters by means of the NCCA labour hotline.

<u>Bargaining Council - Collective Bargaining:</u> Bargaining councils provide a platform for employers and trade unions to negotiate and conclude collective agreements that govern conditions of employment, wages, benefits, and other industry-specific matters.

NCCA KZN Branch of then currently have a Bargaining council, and an application has been submitted for a Regional Bargaining council for Area A as per the Sectorial Determination 1 for the Cleaning Sector.

Networking and Communication - NCCA branches hold members' meetings four times per year.
