NCCA Recognition and Advocacy - The NCCA was established in 1987 with the goal of creating professionalism in the cleaning industry and is officially recognised as an Employers Association by the Department of Employment and Labour.

<u>Code of Ethics - NCCA</u> members commit themselves to a <u>Code of ethics</u> thereby ensuring that customers can rely on the member's adherence to ethical business norms and standards.

NCCA Membership Certificate - An NCCA membership certificate is recognition of the holder's compliance with all material aspects of the legislation specifically applicable to the contract cleaning industry in South Africa.

Ensuring Compliance - During a NCCA compliance Audit, an experienced, independent compliance auditor will verify compliance. This benefits customers by reducing the exposure to financial and reputational risks associated with using the services of a non-compliant service provider.

<u>Compliance workshops -</u> These workshops are offered on a regular basis with no cost to members. These workshops are aimed at assisting members in ensuring compliance and understanding the benefits thereof.

NCCA Members Handbook - This handbook is a resource provided to members and offers a basic guideline relating to the legislative requirement within the Contract cleaning industry.

<u>Bargaining Council - Collective Bargaining:</u> Bargaining councils provide a platform for employers and trade unions to negotiate and conclude collective agreements that govern conditions of employment, wages, benefits, and other industry-specific matters.
